Sweepstakes Entry Period: June 2 – June 30, 2017

Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID IN ALASKA, HAWAII, PUERTO RICO AND WHERE PROHIBITED OR RESTRICTED BY LAW.

ELIGIBILITY: Sweepstakes is open to all legal residents of the forty-eight (48) contiguous United States and District of Columbia, who are twenty-one (21) years or older and have a valid email address at the time of entry. Administrator's computer is the official clock for purposes of the Sweepstakes. By entering the Sweepstakes, you have the opportunity to opt in to receive future free travel information from Prize Providers.

LIMIT: Entry is limited to one (1) entry per person, household or email address. Use of any automated system or agent to submit entries is prohibited and will result in disqualification.
